MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) is made and entered into effective this 15th day of September, 2016, by and among ~~SOUTHWEST LOUISIANA HOSPITAL ASSOCIATION~~,
~~D/B/A LAKE CHARLES MEMORIAL HOSPITAL~~, a Louisiana nonprofit corporation (SLHA),
the Board of Supervisors of Louisiana State University and Agricultural and Mechanical College
(LSU), and the State of Louisiana, acting through the Office of the Governor.

Agreements have been in effect the Parties believe are needed to make the system financially sound and medical education must be further reformed in order to be sustainable;

WHEREAS, in order to begin the process for reformulation of these partnerships and systems, the Parties agree that the CEA and, to the extent applicable, the Related Agreements must be modified in key areas and, in the interim, the Parties agree that this MOU, in the terms of the CEA and/or Related Agreements;

WHEREAS, the Parties believe this MOU is necessary to, among other things, facilitate health care delivery and medical education; and

WHEREAS, in order to achieve these goals, the Parties agree that they need to work together to develop a strategy for longer staying in order to maintain our competitiveness and

"**WHEREAS**, the Parties respectively agree, notwithstanding anything to the contrary, that negotiations will be conducted in good faith and in accordance with the principles of the World Trade Organization, the General Agreement on Tariffs and Trade, the GATT, and the World Bank's International Trade Rules.

Therefore, the Parties agree as follows:

- a. **Establishing a joint language and currency, the euro, which may be used by the parties in their negotiations and, if necessary, in any other documents, including contracts, they may enter into, provided that such documents, together, the parties agree that they will be subject to the jurisdiction of the European Court of Justice.**
- b. **To co-operate with one another in the preparation of the joint negotiations, including joint meetings, joint delegations, and joint working groups, and to keep the other party fully informed of the progress of the negotiations.**
- c. **To establish a joint committee, which may be composed of representatives of both parties, the purpose of which may be to facilitate the preparation and carrying out of the negotiations.**

7. Pursuant to H.B. 111, money and services shall be provided to the CHART for a period of one year, subject to the availability of funds and the performance of the CHART in accordance with the terms and conditions of this agreement.
