# **Updates from the SACSCOC Steering Committee and QEP team**March 12, 2013

### **Background:**

LSU is in the midst of its reaffirmation preparations for our

decennial accreditation by the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC) ó NUWøu"tgikqpcn"ceetgfkvkpi"dqf { (808 institutions from VA to TX).

- o permits our students to receive federal funding for their education
- o allows our faculty to be supported by federal grants and contracts.

SACSCOC accreditation provides assurances to all other accrediting organizations, which in turn accredit individual degree programs (e.g. AACSB). Without SACSCOC accreditation, none of the other discipline specific accreditations would be possible.

To be reaffirmed for accreditation LSU must demonstrate that it is compliant with the 98 Principles of Accreditation set forth by SACSCOC; including the development of a Quality Enhancement Plan (QEP).

March 11-13, 2014: Dates of the on-site SACSCOC reaffirmation committee visit to LSU.

December 9, 2014: Announcement date for reaffirmation of accreditation for LSU.

## **Recent/upcoming events and activities**

- 2) The Steering Committee has generated initial responses to most of the SACSCOC principles and is in the process of refining and adding appropriate evidence of compliance. Additional information requests will likely be made to various groups at LSU in the next several months.
- 3) An external SACSCOC accreditation consultant has visited LSU twice (October 29-30, 2012 and January 14-16, 2013) cpf"rtqxkfgf"kprwv"qp"NUWøu"rtqitguu"kp"vjg"ceetgfkvcvkqp"rtqeguu. Based on her input, we have modified the way in which we approach the principles with the supporting documentation. She continues to give feedback and will return late April.
- 4) An LSU accreditation team attended the SACSCOC Annual meeting (Dec. 9-12, 2012) to interact with SACSCOC officials and our consultant on issues specific to LSU.
