- 5.) The Chapter must comply with the national organization's bid to initiation national policy as well as University policies.
- 6.) The Chapter must become an alcohol-free facility immediately. The chapter may petition after January 1st, 2019 to host approved events with alcohol at the fraternity house. The chapter may host one non-alcoholic event in fall 2018, with approval from Greek Life. The chapter will develop a plan for compliance and how the chapter will utilize their internal judicial process to address any violations.
