Based on the information presented and discussed, the Alpha Gamma chapter of Pi Kappa Alpha Fraternity accepts responsibility for their actions, which constituted a violation of LSU's Code of Student Conduct, specifically violating PS-78. As a result, your chapter has submitted the Chapter Enhancement Plan, to meet the requirements of the partnership process with Greek Life and Student Advocacy & Accountability:

As a result of the incident that occurred on October 27, 2017, where Pi Kappa Alpha Fraternity members and guests had alcohol in the fraternity house that was a violation of PS-78, the following will occur:

Organization Letter of Reprimand

This accountability status will be effective February 6, 2018 through December 31, 2018.

With respect to the information listed above, the following additional sanctions/stipulations apply:


1. The chapter will implement "The Pike 12" program, which will be established by January 15, 2018, approved by January 22, 2018 and active by January 29, 2018. Documentation of the bylaw change will be submitted to SAA by February 9, 2018.
2. The chapter will present LSU and Pi Kappa Alpha alcohol policies to members by a Greek Life approved speaker where 90% of the members will be present. Documentation and attendance will be provided to SAA by Feb. 19, 2018.
3. The chapter will forfeit one social activity for Spring 2018, Pike's of the Caribbean. Members must be informed by February 5, 2018. Documentation of this conversation will be submitted to SAA by February 15, 2018.

The Enhancement Plan and Accountability Outcome will be kept on file in Student Advocacy & Accountability within the Office of the Dean of Students. The enhancement plan will also be shared with all relevant LSU and headquarters staff.
